**II. CALL TO ORDER:** President Rebecca McDannold called the meeting to order at 3:00 p.m. April 1, 2019.

### **III. OFFICER REPORTS:**

- A. **President** Rebecca McDannold: President remarks: Rebecca revisited the need to change the by-laws regarding the date of the monthly board meetings after last month's discussion. It is difficult to conduct business while customers are visiting the gallery when meetings are held during operating hours. She presented two statements for review and approval.
  - 1. The PAGG membership meeting shall be held the second week of the month in October, January, April and July.
  - 2. The governing board will meet one time a month during the first week of the month. Brenda Price presented the statements in a motion and Vickie Maley seconded it. The motion passed. The proposed statements for the by-laws change will be presented at the next members' meeting for a vote.
- B. **Secretary** Vickie Maley: Roll was taken. Minutes for the March 4, 2019 meeting were approved. Gary Rubin moved to accept the minutes, and Barbara Hopkins seconded the motion which passed.
- C. 1st Vice President Barbara Hopkins: Barbara reviewed the process she proposed at the March meeting for submitting and maintaining records for new work in the main gallery and in the corner shows. She also showed the new wall cards. Members will keep their own ledger in the gallery. The board reviewed the documents and process and agreed all should be presented to the members at the next members' meeting. Barbara will have printed copies of all information. The documents and process will be used at the April rehang.

NOTE: Take down and delivery of new work: Tuesday 4-23-2019 from 2-5 pm Rehang: Wednesday 4-24-2019 from 8-11 am. The theme for the next show is "Fresh and Bold".

D. **2nd Vice President:** Jeanne Tennyson: Rehang at the Isle of Amelia Parkway Suites will be April 29. There is no theme. Larger pieces will show better at this venue (about 79 pieces of up to 29" with some space for larger pieces). She requested that any artist wishing to hang at the venue, please email her with the number of pieces to be displayed.

She reviewed that the Osprey rehang was held on March 11; the next one will be held in July, date TBD.

E. **Treasurer's Report** Pam Vieser reported March sales of \$3,291. The board also discussed the issue of the cash box change. Pam reported the cash box was short about \$17. Artists
